MK reminded all to register for federation membership, this is required for all kenshi and it is a requirement for us to report on the number of members to our parent bodies EKF, FIK and IMAC, and it is also required in order to grade or participate in national or international events.

Currently have 103 registered members, and some are known not to have registered.

## Update on affiliate activities

KC gave a brief update on IMAC funding opportunities which have been available over the past year. She stressed that there will be additional funding opportunities, and that it is important that all instructors are Garda Vetted in order for a club to be eligible to apply for funds.

The issue of the expulsion of the Russian Kendo Federation from the EKF was discussed, and participants were informed of the ruling by IMAC to bar athletes from IMAC-affiliated clubs from participating in competitions at which Russian athletes are also participating, in line with the International Olympic Committee guidelines. It was clarified that this means athletes representing Russia and does not impact the ability of Russian born members of KnhÉ to participate fully in all events.

### Motions - constitutional amendments

## 1. Remove the following notes which should be in minutes not part of the constitution

"[AGREED: **1.1** Kendo na hEireann will continue to be the official name of the Irish kendo Federation. We will not use the abbreviation of IKF we will continue to use KnhE or KnhÉ.]"

"[AGREED: 2.2 / 2.3 Specific roles for all elected and nominated officials will be created with measurable goals/targets included. These will be included in the articles of association.]"

[AGREED: **5.2** A new policy for establishing and supporting new clubs is to be developed. This will be referenced in section 5.2 as an appendix.]

[AGREED: **5.4** There were many concerns about our existing Insurance arrangement. The ideal is to have one insurance policy for everyone in the federation. It was agreed this was a priority for the BOM over all other actions. All federation members should use their contacts for help in any way on this matter.]

#### 5. Remove the entire section 1.5

#### 1.5 Licence

- a) The only licensing body for Kendo, Iaido and Jodo in Ireland is Kendo na-h'Eireann.
- b) Licences are renewable and dated from 1st January each year.
- c) Only current licence holders or members may participate in the activities of Kendo na-h'Eireann and the EKF/FIK.
- d) The licence's are individual and not transferable.
- e) Forms and books are available from the Secretary.
- f) Each art shall require a license.

Instead insert into membership 4.1 that says

"In principle, only current and fully compliant members of Kendo na hÉireann may participate in the Irish National Championships and be members of the Irish National Squad. Participation in other national events may be extended to non-members at the discretion of the management committee."

### 6. Add new chapter on Club recognition

Proposal to add it as chapter 4, and renumber all subsequent sections

#### Chapter 4: Dojo Recognition

- 4.1. Members of Kendo na hÉireann, except life members, should be a current member of a recognised Kendo na hÉireann dojo
- 4.2. Any dojo may apply for recognition according to the Kendo na hÉireann new dojo policy, and after a probationary period can be granted full membership
- 4.3 Dojos must comply with all policies and rules of Kendo na hÉireann, the Irish Martial Arts Commission, Sport Ireland, the European Kendo Federation and the International Kendo Federation, this includes anti-doping regulations, Garda vetting rules, child protection laws, and any other legal requirements or policies or rules set by governing bodies
- 4.4. Where a fully recognised club is noncompliant with article 4.3 they will lose recognition
- 4.5. Upon becoming compliant with article 4.3,, a club will be entitled to apply for reinstatement
- 4.6. Where a club has lost recognition, their members will also automatically lose their membership. Club member's fees may be refunded upon review
- 4.7. Members of a club which has lost recognition will be entitled to membership if they are accepted as members of a recognised club, and any fees paid for the current year will be carried over to their renewed membership

#### Discussion

The term "new Dojo Policy" above should not say new, instead we should discuss what to call this in AOB and then replace this in the proposed text above. This amendment was accepted and the above proposal went to a vote with the understanding that the term "new dojo policy" would be changed.

## 7. Remove references in Chapter 7 to hosting club for the Nationals as we do not do this anymore

#### I.e. remove

- "c) Hosting club may decide to have additional classes.
- e) The hosting club must show they have membership and resources adequate to running this event.

#### 7.3 Hosting club

- a) The location of the Irish National Championship will rotate between each member club of the Federation on an application basis. Subject to Management Committee approval.
- b) The hosting club will be responsible for the costs of hosting the competition, and will be able to decide the prices for entry to the competition.
- c) In cases where the club can demonstrate financial hardship, or where significant expenditure is required which would be beyond the hosting clubs financial means, the hosting club may apply to the Federation for a grant. The amount of assistance awarded will be decided by the President, in conjunction with Treasurer, having due regard to the financial position of the Federation.
- d) New clubs can avail of an exemption from hosting the competition during their first three years."

- c) In any given year, the management committee may, at its discretion, extend an invitation to one or more dojos in Northern Ireland to send a team to participate in the Irish National Championships team competition
- d) any invitation as referred to in 7.c will not extend to the individuals competition, but may include other categories such as women and juniors if these are held

#### 10.2 Developing links with other sensei

The President of the Federation will be responsible for fostering links with kendo Sensei, for the benefit of the members of Kendo na h'Eireann.

Individual clubs may develop links with Sensei, and arrange for visits and host seminars by visiting Sensei, with the approval of the President of the Federation.

In all cases, member clubs will be answerable to the President of the Federation as regard to how they conduct their relationship with Sensei.
